

II VISUAL TEXTILE PHOTOGRAPHY CONTEST

The Association of Textile Creators of Madrid (ACTM) launches the call for the 2020 edition to all creators who want to take part in the **II Visual Textile Photography Contest**, which **will be held on November 28, 2020 online**, within the framework of the activities it has programmed in the field of textile crafts.

PARTICIPATION RULES

- We ask for TEXTILE PHOTOGRAPHS whose basic component shows the textile, which can be reflected in a different way: photographing some textile element, a photo-embroidery, using old photos for its composition, a family photograph; photographs of textile spaces, textile buildings, people wearing something textile; provided that the textile intervenes in some of the aspects.

Photographs should not include portrayed people whose faces can be identified without the consent of the person, in accordance with art. 7 of Organic Law 1/1982, on the protection of honor, privacy and self-image.

- **All artists who wish may participate.**

- Admission period is from **September 30 to October 30, 2020, both inclusive.**

- Each artist may submit up to a **maximum of 3 photographs** related to the theme of the contest.

- Photographs must be in **digital format (jpg)**, they may be in **black and white or color.**

- The photographs presented may be edited with photographic editing and retouching programs in order to improve them or correct brightness and color values, but in no case will work with a consistent and implausible alteration to reality be accepted.

- **It is recommended that they do not exceed 5Mb and have a minimum resolution of 1700x600.** They must be unpublished and not have been presented in any other contest or competition, nor have they been presented in any type of support or medium (written publications, web pages or social networks).

- Participating artists **who are not members of the ACTM will have a participation fee of 15 €** (the registration form will include information about how to make the bank transfer).

- Photographs that do not meet the above criteria or do not adapt to the theme of the contest will not be admitted.

- The prizes of this contest are sponsored by the ACTM.

- **First prize for creativity:** **Valued at 200 €** - may be exchanged with participation in one of the workshops given by the partners.

- **Second Creative Partner Prize:** **Valued at 135 €** - may be exchanged with the one-year membership fee.

* The management of the prizes will be carried out through the coordinator of the contest formed by the Board of Directors of the ACTM.

- Photographs will be sent through the attached electronic form.

- The anonymity of the authors will be preserved in the selection phase of the works, in the voting and in the ju-

ry's decisión. The authorship will be made public once all the prizes have been awarded.

SELECTION, JUDGMENT AND PUBLICATION OF WORKS

- From the photographs presented, **the jury composed of the Board of Directors and a group of artistic specialists** will select the set of photographs presented. The selection made will be published on the **instagram of the ACTM**.

- Each of the awards will be for a single photo and no participant may be the winner of more than one award. If the circumstance arises that the two most voted or selected by the jury were from the same author, the decisive vote will be in charge of the Board of Directors.

- The jury will choose the first and second prizes, among the most voted photographs, for which they will assess aspects such as quality and originality in the treatment of the subject. **The decision of the contest, resulting from the vote of the Board of Directors and the Group of artistic specialists**, will be communicated to the winners and will be published on the ACTM website. The rest of the photographs presented may also be published on the ACTM website.

- **The awards ceremony will be held in an ONLINE event** that will be timely communicated to the winners and the rest of the participants. (Previously agreed with them how to deliver said award).

- Participation in this contest implies full acceptance of the bases of this call. **The author retains his / her moral rights over the photographs submitted and grants, free of charge without time limit, to the Association of Textile Creators of Madrid (ACTM) the total or partial reproduction rights for their publication, communication or dissemination in electronic media or printed as it deems appropriate and in any format.**

By extension, photographs may be used by the Madrid Textile Creators Association (ACTM) for exhibition purposes in any medium or format, including all ACTM portals, social networks and applications.

Likewise, the Association of Textile Creators of Madrid (ACTM) may present the works presented on its portals for use and distribution by third parties, and this will be based under the "CC 4.0 International license. Recognition".



- The Association of Textile Creators of Madrid (ACTM) are excluded from any liability due to non-compliance by third parties with the conditions of use of the aforementioned license.
